#### 2. Yearly training hours

Letter

#### 3. Panel for national conference

#### 4. Other Just in Time updates

Webinar for Judge Sullivan

• A webinar will be held May 19<sup>th</sup> for Judge Sullivan. Discussion will be what the next steps for this project are. This includes more advocacy efforts for better transitions. Judge Sullivan will be speaking about what the webinars have accomplished at the conference in Cleveland.

Webinar for Normalcy

- The last webinar of the series will be held May 25<sup>th</sup> from 1-2:30pm. Barbara Buckley will be speaking about the statewide policy for normalcy written for both DFS and private agencies.
- Some topics will include what foster parents can and cannot do, what being a prudent parent means, as well as a panel discussion.

#### **5. Preservice rewrite update**

- The preservice rewrite is approximately ¾ completed at this point. We expect it to be fully completed by September 2016. We are partnering with the Youth Law Center in this process.
- The goal of the preservice rewrite is to develop foster parent training that is specific to our community, drawing from case studies.
- The training series will be 7 weeks long and cover seven topics of mastery. There will be a pre-test and post-test implemented to measure the effectiveness of training.
- Once this is completed, it will be the first and only evidence-based training nationwide. This is an exciting tool that we will be able to share with others. The goal is to create a process that each community can adapt to their own specific needs.
