#### **Business-**

- 1. Ice Breakers Liz
  - a. Workgroup November 26, workers and foster parents throughout the region
    - The Ice Breakers will be implemented after the workgroup has had their meeting. Then it will start a trial run in probably, Elko, Fernley and Fallon areas. This will give enough feedback that is needed to revamp the Ice Breaker meetings if necessary, before full implementation to all DCFS offices. There is NO set date for this implementation to start.
    - Question from Gimarie- will there be information out regarding the Ice
       Breakers. Response from Liz there will be an email with the information to all the workgroup participants.
    - Question from Carroll Ann What is the Ice breakers? Response from Liz- An Ice Breaker meeting is a meeting between the birth family, foster family to meet and discuss the needs of the child. There will be four worksheets: foster parent worksheet to discuss the routine of their home, sports, animals, meals, and other activities. The birth parent worksheet will give more information on the child, likes, dislikes, what makes them comfortable, etc. There is a child worksheet for the child to fill out if necessary. The last form will be an evaluation form to see what

- went well and what didn't not go so well. Also, a co-parenting agreement form.
- Question from Pam Do we have these forms available? Response from
  Liz forms are not available now until everything has been approved and
  implemented. Then these forms will be scanned to the drives. Once
  forms are filled out forms will be scanned to drive to track the trends.
- Question from Carroll Ann Do all the social workers/case workers know about this? Response from Liz – Yes and No. That is why the workgroups are going to do it first to make it more streamed lined. Once that is done, then it will be implemented and an All Staff meetings will happen in each area and implement the Ice Breakers.

#### 2. Comfort Calls - Liz

- a. Will implement around the same time as Icebreakers
- Procedures for the call have been developed, being approved by upper management.
  - Comfort Calls explained by Liz- They are calls between the foster parent, bio-parent and child to give them a chance to talk reducing trauma for all involved. It is the first contact once the child is removed from the home to discuss any special needs of the child and how to comfort the child. This should be done right away within the first few hours of removal if possible.

## 3. Caregiver Courier - Kathy

- a. What would you like to see included in the Courier?
  - Starting January 2019, there will be emails sent out to all foster families,
    on the QPI website and on the Facebook foster parents page, giving
    valuable tidbits to the foster parents. For example: information on
    PRIDE, IEP's, court system, and licensing, etc.. The more feedback the
    better as Kathy wants this to be beneficial to the foster parents.

- Statement from Megan Social workers need to have these courier emails as well to make sure they know what is going on, and so social workers and foster parents can be on the same page.
- Statement from Kathy Need participants by others to put in information regarding topics and expertise. Pam could talk about her specialty when working with bio-parents and foster parents, etc.

### 4. Transitions - Liz

- a. Betsey has made it a requirement that staff take on of the following two

  - By the end of the month all staff should take one of the two transition plan videos. New transition form will be implemented soon. They will first go to the supervisors. Form will include but not limited to child info, where child will be going, where they came from, visitation schedule (at least 4 visits already set), etc. This transition plan will help child from feeling so scared when having to go to a new family home, whether that be from bio-parent to foster parent or foster parent to foster parent.
  - Keep in mind foster parents will probably see this form when child is placed.
